## DIRECTIONS TO LAKE OF DREAMS ON REVERSE SIDE

**Directions:** Lake of Dreams (LODI): 50 minutes from Clayton.

Hwy 170 North to Hwy 270 (Chicago) to Hwy 367 (Alton) exit North approx. 8 miles and continue across the Clark Suspension Bridge. At Lights turn left and continue past Argosy Casino & grain elevator to lights and turn left onto (River Road Rte. 100).

Follow River Road approx. 5 miles to Clifton Terrace Rd (first lights you will come to) and turn right up the hill to Delmar (dead end) and turn left onto Rt. 3. Continue 5 miles until Route 109 junction and take 109 to the right (Jerseyville sign is 8 miles).

Continue for five miles to Lodi Road and turn left at white sided house. Paul Melnuk's home about a mile down the road on the left side (Cedar House) with mailbox #24167 at the driveway.

Alternate Directions From Alton if River Road (Rte. 100) is Closed: Continue on Hwy 67N at the Argosy Casino & grain elevator for approximately 8 miles and turn left on McClusky Road/CR 6 for 3.6 miles and turn right on Route 109.
